Indian Institute of Management Lucknow Noida Campus invites applications from eligible and experienced candidates including retired Medical Professionals for the position of **Medical Officer (Part Time)** purely on contract basis initially for a period of one year extendable further up to two years, subject to satisfactory performance of the incumbent & need of the Institute. GENERAL CONDITIONS:

1. The selected candidate (s) will be engaged on contract basis initially for a period of one year, the same may be extendable upto further two years, subject to satisfactory performance of the incumbent & need of the Institute.
2. Mere fulfilling the eligibility criteria does not guarantee that the applicant will be shortlisted for the Interview. The Institute reserves the right to restrict the number of shortlisted candidates for further recruitment process to a reasonable number on the basis of higher qualifications and/or experience.
3. The date for Interview will be communicated later to the shortlisted candidates **through email ONLY**. The candidates are advised to check their emails regularly.
4. The shortlisted candidates will be required to bring all original Certificates, Degrees and other documents pertaining to their educational qualification, professional qualification, work experience, age etc. for verification purpose at the time of second phase of Interview along with one set of photocopies of these documents.
5. Crucial date for determining the age limit shall be the closing date for the receipt of applications.

6. **Selection Process-** The Selection Process would be conducted in two phases one online and subsequent one- to- one interaction, if shortlisted in first phase (online process).
7. In view of the current COVID-19 situation, the first phase of selection process may be conducted in online mode (through Google meet/Zoom conference etc.). Candidates are required to mandatorily mention their **Gmail ID** in application form.
8. The Institute reserves the right to relax the eligibility criteria at its discretion.
9. The reservation for SC/ST, OBC and Persons with Disabilities will be applicable as per Government of India rules.
10. The Medical Officer is required to visit three days a week on part time basis in the campus. Further the Medical Officer should be available round the clock and emergency duties on call basis at any point of time.
11. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the candidates (Applicants).

13. The panel of selected waitlisted candidates will be valid for one year from the date of approval of Competent Authority and Institute can make appointments in future also by operating the panel within the validity period.
