Indian Institute of Management, Lucknow, an autonomous body, under the Ministry of Human Resources Development, Government of India invites online E-tenders in Two-Bid Systems (i.e., Technical Bid & Financial Bid) from Scrap Dealers/ Individuals and others who are interested in buying unserviceable/unreparable items on “AS IS WHERE IS BASIS”. A free view of NIT is available on Govt. E-Publish portal i.e. <https://eprocure.gov.in/epublish/app> and on Institute website www.iiml.ac.in.

The tender documents comprise of **Technical bid** and **Financial bid**. It is requested to download the Tender on acceptance of terms & conditions. The technical bid and financial bid (hard copies) are to be submitted to reach at IIM Lucknow on or before the last date & time for submission mentioned in the tender document.

1. Items available for sale:

The total items have been divided in two parts:

- i. Annexure-A: This contains the name of items with the exact quantity available at various locations in the Institute. The bidders are required to quote the unit rate (inclusive of GST, as applicable on each item and TCS) for each item, multiply the rates with the quantity, mention the resultant amount and then total the amount at the bottom. These items are treated as LOT-1.
- ii. Annexures-B: This list contains the material / items, which are in the dismantled form and will be sold on per kilogram (kg) basis. The estimated weight has been mentioned in the Annexure/ List. The bidder are required to quote the rate per kg for each type of material and multiply the estimated weight mentioned in this Annexure and fill the resultant amount. The sum / total of such amount shall be calculated and filled at the bottom. These items are treated as LOT-2.

The items mentioned in this list are in non-working/damaged condition, few items may have some parts missing. Therefore, the bidders are strongly advised to visit the site (as per date & time mentioned above) and inspect the material before submitting the bids. The rate shall be quoted based on the present condition "AS IS WHERE IS BASIS".

2. Eligibility Criteria for bidders:

The bidder can be an individual or partner/ proprietor of a firm/ Company with a valid PAN card.

The bidder shall submit a self-attested copy of the PAN card and the filled, signed & stamped 'Annexure-I (Technical bid) and Annexure-'A' & 'B' (Financial Bids) as per the process for submission shown below.

3. Bid submission process, evaluation process, actions required by the successful bidders, timelines for successful bidders for deposit of quoted amount, lifting the material from sites and penalties:

The technical bid and the financial bid should be sealed by the bidder in separate covers. The envelope containing the Technical Bid (Annexure-I) shall be duly super-scribed "NIT number, Technical Bid for Scrap and Name of Bidder" on envelope. Similarly, the envelope containing the Financial Bids/ rates (Annexures-"A" & "B") for Scrap shall be super-scribed "NIT Number, Financial Bids and Name of bidder". Both these sealed envelopes are to be put in a bigger cover which should also be sealed and duly super-scribed – NIT Number, Bid for Scrap, and Name of

the bidder. The technical bids are to be opened by the Tender Evaluation committee at the first instance and the technical bids will be evaluated.

The evaluation of bids will be done by the committee constituted for the purpose. The committee members will evaluate the bids as per submitted documents. The bidders are required to submit the filled form (Annexure-I), copy of PAN card and proof of deposit of EMD or DD will be declared as Technically qualified.

Financial bids of only technically qualified bidders will be opened. The bidder quoting the highest rate (total of all rates i.e. unit rate multiplied by the quantity) for items mentioned in the Annexure-A, will be declared as the Successful bidder for purchase of items mentioned in the Annexure-A (LOT-1).

Similarly, the bidder quoting the highest rate (total of all rates i.e. per kilogram (kg) rate multiplied by the estimated quantity of that particular metal / material / item) for items mentioned in the Annexure-B, he will be declared as the Successful bidder for purchase of items/materials mentioned in the Annexure-B (LOT-2).

The quoted rate shall be inclusive of GST, as applicable and TCS @ 1%.

The success bidder will be required to take following action on receipt of the letter/ communication:

1. Deposit the quoted amount within 3 working days in the following Institute Bank Account and submit the proof of deposit to the Administrative Officer (Purchase & Stores), IIM Lucknow:

2. In case, the successful bidder (the bidder quoting the highest rate for particular LOT – H1 bidder) is not able to deposit the quoted amount within 3 working days, a penalty of Rs.5000/- per day will be imposed on such bidder. In case, the successful bidder does not deposit the amount within 10 working days, the EMD deposited/submitted by the bidder will be forfeited and he will be debarred for a period of two years for participation in the tendering process at IIM Lucknow. Further, that particular LOT will be offered to the bidder quoting the 2nd Highest Rate (H-2 bidder) at the rate quoted by H1 bidder. If H2 bidder accepts to buy the material at the rate quoted by H1 bidder, the H2 bidder will declared at the successful bidder.
3. After deposit of amount, the bidder will have pick the material “AS IS WHERE IS BASIS” from the respective locations within 7 working days. The required labour and Transport has to be arranged by the successful bidder. The material shall be loaded in presence of the committee members (names will be provided by the AO-P&S) after verifying the quantity of the items/ material.
4. If full quantity of the items/ material is not picked within 7 working days, a penalty of Rs.5000/- per day will be imposed on such bidder. Further, in case, the material is not removed/ picked up from site within 15 working days, the amount deposited by him will be forfeited and he will be debarred for a period of two years for participation in the tendering process at IIM Lucknow.

5. For items/material mentioned in **Annexure-B**, if the actual quantity is more than estimated quantity mentioned in this Annexure, the bidder will be required the amount for excess quantity before picking excess quantity.

If the actual quantity is less than estimated quantity mentioned in this Annexure, the amount towards the shortage (quantity mentioned reduced by the actual quantity) will be refunded to the bidder.

6. Under no circumstances the successful bidder shall lift any material other than the items mentioned in Annexure: "A" and "B", lying inside the premises of designated area. In case, there are two successful bidders i.e. for material mentioned in the Annexure-A and for material mentioned in the Annexure-B, the successful bidder for Annexure-A shall not pick/ lift the material mentioned in Annexure-B or vice-versa. The successful bidder will be responsible for the conduct of the transporters and labours hired by him. Any misconduct by these will attract action against the successful bidder.

In such scenario, appropriate action, including administrative/ civil action will be taken against the bidder violating this condition.

7. The successful bidder is required to bring two weighing machines with a capacity to weigh up to 500 kg. These machines will be tested by IIM Lucknow and the weight of the material will be

4. **Disqualification:** The proposal is liable to be disqualified in the following cases

- I. Proposal is not submitted in accordance with this document.
- II. During validity of the period, or its extended period, if any, the bidder increases his quoted prices.
- III. Proposal is received after due date and time
- IV. Proposal is not accompanied by all requisite documents.
- V. Information submitted in the tender proposal is found to be misrepresented, incorrect or false, accidentally, unwittingly or otherwise, at any time during the processing of the contract (no matter at what stage) or during the tenure of the contract including the extension period if any.
- VI. If Quotation is received without EMD or valid MSME certificate issued to the bidder for similar services.
- VII. If Quotation is not addressed to The Chief Administrative Officer (CAO), Indian Institute of Management Lucknow, Prabandh Nagar, Lucknow-226013.
- VIII. If the bidder has been black listed by any Government/PSU/Autonomous organization.

5. **Earnest Money Deposit (EMD):**

Bidders are required to deposit an amount mentioned on first page of the tender document. Towards Earnest Money Deposit (EMD) to below mentioned bank account of Institute on or before the last date & time mentioned above or submit Demand Draft drawn in favour of "Indian Institute of Management Lucknow" payable at Lucknow. EMD through any other form will not be accepted. UTR number / Transaction ID/DD Number and date of Deposit/Transfer of EMD / DD shall be mentioned in Technical Bid at appropriate place.

Deposit of EMD is mut for all bidders and No bidder is exempted from deposit of EMD.

EMD of all unsuccessful bidders will be returned after finalization of the tender. EMD of the successful bidder will be returned only after receipt of quoted amount. In case, the bidders provide false or misleading information or make changes in the downloaded document or provide forged document or hide facts relevant to tender / bidder, EMD of such bidder may be forfeited. Such action can be taken at any stage of the bidding process i.e. during or after process.

6. DEBARRED/BLACKLISTING OF BIDDER:

- I. The bidder shall be debarred from the bidding if he has been debarred by any procurement entity on the grounds convicted of an offence, under the prevention of corruption act 1988 or the IPC or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract.
- II. In case the bidder hides the fact of his debarments and found it later stage during the evaluation, the bidder shall be disqualified for further evaluation or the contract shall be terminated, if awarded. More over the bidder shall be debarred for two years for hiding the fact of debarment. In this case earnest money/Performance Security (whatever is applicable) will be forfeited
- III. Breaching of Integrity pact 1975 or whatsoever provisions exists in this regard.
- IV. In case the bidder withdraws his bid after last date for submission of bid or does not accept the work order on award of work, the bidder (s) may be debarred / blacklisted.
- V. In case the bidder provides false or misleading information in the bid or encloses forged / fake documents with the bid, the bidder (s) will be debarred / blacklisted.
- VI. Any attempt to cheat or hiding of material facts related to the information sought in the Technical bid will lead to disqualification and the bidder will be debarred/blacklisted.

7. Disclaimer Clause:

IIM Lucknow has the discretion and right at any stage to cancel/add or amend the information, terms, procedure and protocol set out in the TENDER DOCUMENT and the bidder has no claims against such right. The institute has unfettered right hereunder to terminate the arrangements at any time without assigning any reason whatsoever. The jurisdiction for dispute (s), if any, shall be Lucknow.

8. FORCE MAJEURE:

Force majeure is hereby defined as any cause which is beyond the control of the contracted bidder or IIML as the case may, which they could not foresee with a reasonable amount of diligence and which could substantially affect the performance of the contract, such as natural phenomena (including but not limited to floods, droughts, earthquakes, epidemics, etc.), acts / directions of any Government (including but not limited to war, declared or undeclared, priorities quarantines, embargos, etc.); provided that either party

shall within 15 days from the occurrence of such a cause notify the other party in writing of such causes. Bidder to note that rains, droughts and monsoons are not part of force majeure and bidder is required to provide all its facility as per the stipulated minimum requirements. The bidder or IIML shall not be liable for delays in performing their obligations resulting from any force majeure cause as referred to the defined above. Hence during the period of force majeure, as indicated and covered above, during which the services are not provided by the contracted bidder or not availed by IIML, both parties will not be liable for their obligations under the contract. Thus the Force Majeure will free both parties from contractual obligations / liability when prevented by such events from fulfilling obligations as the same will be suspended for the period of Force Majeure.

9. DISPUTE SETTLEMENT & APPOINTMENT OF ARBITRATOR:

“All disputes or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of the Tender and the resulting agreement or the breach thereof that cannot be settled by good faith and negotiations between the parties within 60 days of the commencement of negotiations shall be settled by referring the dispute to the Director, IIM Lucknow, who may either himself decide the dispute as Arbitrator or appoint some other person as Arbitrator to adjudicate the same, who shall be unconnected with IIM Lucknow. The proceedings will be governed by the provisions of the Arbitration & Conciliation Act 1996. By consent of parties the jurisdiction of all other courts are excluded and the courts at Lucknow alone shall have jurisdiction. The language of the Arbitration shall be English.
