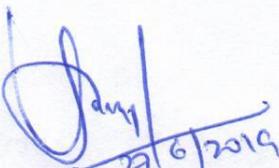

### **SCOPE OF SERVICES:**

- The proposed internet links will be installed at the Computer Centre, IIM Lucknow. The services involve supply, installation, commissioning and management\* of the link for one year. (\*Refer point 13 for further details on management).
- Estimated duration of Commencement of services: **Maximum 4 weeks from the date of placing order.**

### **BID INFORMATION AND INSTRUCTIONS TO BIDDERS :-**

- All interested service providers are requested to submit tenders through e-portal only i.e. [www.eprocure.gov.in](http://www.eprocure.gov.in).
- Tender document is available on the website <http://eprocure.gov.in>, and information also available on Institute's website i.e. [www.iiml.ac.in](http://www.iiml.ac.in). The interested bidders may download the tender document containing the terms and conditions.
- The Parties / agencies shall go through the technical specification provided in tender document before quoting the rates. The rate should be mentioned in figures as well as in words inclusive of all charges, taxes and levies
- The bidders shall upload their bids, a scanned copy of EMD on [www.eprocure.gov.in](http://www.eprocure.gov.in) along with the documents as per tender document and Bid contract norms. The bids shall be opened on the mentioned date in the Bid Information Sheet. The technical Bids shall be scrutinized/verified by IIML in terms of the tender, the PRICE BIDS will be opened of only technically qualified bidders. The date and time for opening of Price Bids will be uploaded on [eprocure.gov.in](http://eprocure.gov.in). (Bidders are advised to visit site regularly till opening of Financial Bid.)

- Within 21 days of receipt of the Notification of Award from IIML, the Successful Bidder should sign a contract with IIML and shall furnish **Performance Bank Guarantee Security** initially to IIM Lucknow for an amount of **10%** of the total Contract Price **valid up to 13** months. Prior to the extension a Bank Guarantee of 10% of the contract value to be submitted for each year.
- Performance security shall be forfeited by IIML in the event of Successful Bidder's failure to complete its obligations under the Contract or breach of contract conditions.
- EMD deposit of **Rs.75,000/-** (Rupees Seventy Five Thousand only) in the form of Demand Draft in favor of Indian Institute of Management, Lucknow payable at Lucknow. The EMD should be submitted in hard copy before the due date of the e-tender opening. Failing which the e-tender shall not be accepted. BID security money shall be forfeited by IIML in the event of Successful Bidder's failure to accept the Award of contract.

4. ISP Should have its own MPLS core network and NLD backbone.
5. ISP Should have valid GST Registration number.
6. ISP Should have own/direct access to international Gateway in India for providing Internet bandwidth.
7. ISP Should have direct peering with Tier 1 carriers to minimize the number of hops and latency to international destinations. Details of Tier-1 carriers with which peering is done are to be provided. It should have local peering, with in India, with at least one other ISP and it should have an aggregate international capacity of at least 10 Gbps at the time of commissioning. An undertaking to this effect is required to be submitted.
8. ISP Should have fully resilient and self healing network architecture on fiber medium for the domestic backbone in India. The complete fiber and transmission systems from Computer Centre, IIM Lucknow, to International Gateway should be of the bidder's own at the time of commissioning. 11. The contract period will be for one year. During the contract period, IIM Lucknow can terminate the service by giving 4 weeks advance notice. In that case, payment will be made only for the period during which service is provided-on a pro-rata basis

#### **C) Payment Terms:**

### **RESPONSIBILITIES UNDER THE CONTRACT:**

The ISP would be responsible for the following:

- Internet Router Port at ISP Gateway for required Bandwidth and 128 Public IP addresses of ipv4/ ipv6 pool.
- The bandwidth should be provided through a fiber link on SDH/MEN ring terminating in Computer Centre, IIM Lucknow and should be made available on Gigabit Ethernet/Optical
- The Primary path and the backup path for internet link between IIM Lucknow and International gateway each should be a single pipe of 200 Mbps
- The maximum latency from IIM Lucknow gateway router should be as under:

The Bidder is required to monitor the latency report at least once every quarter or whenever asked for.

- The ISP should provide Managed services for monitoring (link up/down, packet drop, latency and other QS parameters) and maintenance of the link. The link (including the last mile) should be monitored on 24x7 basis by the provider. SNMP access to the IIML Gateway Router will be provided for monitoring. A dedicated service manager should be there who will liaison with the NOC in case the link goes down. This will include reporting, ticket generation and follow-up action. These services will be provided by the ISP directly and not through channel partner.

- The service provider should have well-equipped operations & Maintenance (O&M) centres staffed with experienced personnel. The service provider shall maintain sufficient spares at the O&M (Operations and Maintenance) centres to comply with committed MTTR (mean time to repair) of less than four hours.
- Installation, commissioning, configuring of the link and hardware/software (Mux, Modems and Router etc. to make line fully functional).
- Annual Maintenance support service (24 hours and 7 days a week) for Bandwidth and equipment.
- ISP or authorised person from ISP will be required to sign Service Level Agreement.

- Either party may terminate the contract after giving three month notice in advance.

### **DISQUALIFICATION**

The proposal is liable to be disqualified in the following cases:

- 2) Late/delayed tender due to any reason, whatsoever, will not be accepted beyond the notified time and date under any circumstances.
